- 6.Maturity of deposits will be notified in writing at least two weeks prior to the date of maturity.
- 7.In case of withdrawal of deposit , the company will be required to surrender the original Deposit Certificate with the endorsement on the reverse to obtain payment of the principal sum plus accrued interest.

Premature withdrawal

- Premature withdrawal will be allowed at the discretion of the management subject to penalty on interest rate.
- Please note that no interest will be paid for withdrawal made before the completion of one month.
